John Weldon requested permission for Snyder's Church to have a bonfire at the park on October 11th. John will be there to oversee the fire. Jeff Beinhower made a motion to allow the church have a bonfire on the small ball field. Carlton Williams seconded. Motion approved.

Bob Foltz will work on getting prices for a backstop and side fences to be installed on the new softball field.

The next meeting will be October 20th 2009.

John Weldon made a motion to adjourn at 7:15. Carlton Williams seconded. Motion approved.
