**OLD BUSINESS:**

The board discussed talking to Heller's and 11/15 Rental about donating a Ditch Witch to dig several small ditches. Jeff Beinhower will follow-up.

Bob Foltz reported that the air fresheners and a case of mist were received and installed by John Weldon and Dave Mills.

Bob Foltz reported that the 3 Cigarette Containers were received and he installed (chained with locks) two at the pavilion and one by the shack bar.

John Weldon reported he replaced some boards on the foot bridge.

Dave Mills reported he and Carlton Williams cleaned up trash on the railroad bed to the upper trail.

Bob Foltz reported that the Duncannon Sportsmen's Club held the Kids Trout Derby at the park June 5<sup>th</sup> and 115 kids attended. The stream was closed to adult fishing on Saturday and next year they may get a permit to close the stream for kids only for two days. Jeff Beinhower helped the sportsmen's move logs for the dam at the bridge.

John Weldon made a motion to order 24 (size large) lime green T-Shirts. Dave Mills seconded. Motion approved. Bob Foltz will talk to the township secretary about wording and where she orders shirts for the township employees.

John Weldon reported the Jim Fuller and Dexter Potter are digging the drainage ditch so he will not pursue an outside contractor for the work.

Dave Mills made a motion to have lime and fertilizer applied to all the fields. John Weldon seconded. Motion approved. Bob Foltz will contact Bonsall's and tell them to add the new football field (about 300' x 400'). Fertilizer and lime were applied 7/14/2010.

**NEW BUSINESS:**

Bob Foltz reported 24 safety green tee shirts have been order from Murray's Monogram, 128 Ridgeview Drive, Marysville, Pa. 957-3267. Should have them in a couple of weeks.

Dave Mills reported all the drainage pipe and boxes have been installed.

John Weldon reported he and Dave Mills cleared a tree from the upper loop trail. Several trees along the stream are down from the high winds.

John Weldon reported the gate at the power line is destroyed, he will notify Jim Fuller and he can contact PPL.

Jeff Beinhower reported that football will begin using the park for practice July 27, 2010.

Shawn Fuller reported that Tuscarora Hardwoods will donate 24 yards of playground chipped wood if we buy 24 yards. Motion made by John Weldon to buy 24 yards of chipped wood. Shawn Fuller seconded. Motion approved. Shawn will talk to Jim Fuller and try to have wood at the park of the Wednesday night work detail August 4<sup>th</sup>.

Dave Mills reported he and John Weldon sprayed foam inside the spring toys to keep the bees out.

The next meeting will be August 17<sup>th</sup> 2010.
