John Weldon reported Softball is getting their supplies out of the snack bar.

Dave Mills reported that Shawn Fuller informed him that Tuscarora Hardwoods agreed to donate 12 cubic yards of playground material if the Recreation Board will purchase 12 cubic yards. Dave Mills made a motion to purchase the material at an estimated cost of \$400. Motion seconded by Bob Foltz. Motion approved. Jeff and Dexter will pickup and deliver the material to the park.

Dave Mills reported that he replaced several boards on the bridge deck.

Dave Mills reported that Jim Fuller was appointed as a member of the Recreation Board at the last Supervisor's meeting. Welcome aboard Jim.

Dave Mills reported that Brit Brant from the Roseglen Methodist Church may have a youth group that would paint the interior of the restroom building. The Recreation Board would supply all materials. Dave will follow up on this idea.

Dave Mills reported the two charcoal grills were installed by the pavilion and the township supplied the stone for around the grills.

Dave Mills reported the wood chips are still needed for the playground. This needs to be coordinated with the township employees.

Jeff Beinhower had concerns about when we start weekly pickups for the dumpster. John Weldon will look into it.

John Weldon presented a letter about people smoking hear the snack bar. Jeff Beinhower will discuss this with Susquenita Midget Football Association (SMFA).

John Weldon would like to request more help from the township employees to help with park maintenance and park needs. Will discuss this with the supervisors.

John Weldon reported he contacted Conoway Enterprises about seeding the bank along Paradise Road and it has been done.

John Weldon reported the two loads of tan bark were spread around the trees.

John Weldon reported that several times the gate and equipment room have been left open. Litter is also a problem. Jeff Beinhower will discuss this with SMFA coaches.

Bob Foltz reported thru Dave Mills that he painted all of the parking lot lines and handicap spaces. He also reported that the DEP water service questionnaire was completed and returned.
