WHEATFIELD TOWNSHIP PARKS AND RECREATION

The Wheatfield Township Parks and Recreation Board met on June 18, 2019 at 6:30 p.m.

PRESENT: Dave Mills, John Weldon, Shawn Fuller, Jim Fuller, Bob Foltz, and guest Dave Linville.

SECRETARY'S REPORT:

Shawn Fuller made a motion to approve the minutes of the May 21st, 2019 meeting. Dave Mills seconded. Motion approved.

Dave Mills made a motion to accept the Treasurer's Report. Shawn Fuller seconded. Motion approved.

Shawn Fuller made a motion to pay the bills. JohnWeldon seconded. Motion approved.

OLD BUSINESS:

(Carry Over) John Weldon presented the following list of things to do in 2015.

- 5. Trim Brush on the hiking trails. (Dave)
- 6. Re-Blaze the trail markers and property boundaries. (Dave)
- 9. Repair area where sand is washing out on ball field #3.
- 11. Cut ground level down from large dumpster to bridge (left side of railroad).
- 12. Build new bridge.
- 13. Purchase top soil to fill in the area around the pavilion and playground.
- 14. Finish filling ruts on field #3.
- 15. Purchase and install new playground equipment (this means expanding the playground area)
- 16. Get more volunteers to help with projects and work details on Wednesday evenings.

Discussion was held and following list of projects was developed for the township employees and summer hire.

- 1. Clear trails and mark trees on trails.
- 2. Clear a trail from the loop trail down to the west end of the Paradise Road Bridge.
- 3. When softball is finished fill ruts on outfield of field #3.
- 4. Pressure wash tractor, gator, mower, inside of restrooms.
- 10. Grade area on field #1 outfield so water can run to the creek.
- 11. Place and grade shale to fill in around pavilion #2.
- 12. Place stone in parking area for pavilion #2 and for road from railroad bed to pavilion parking area.

Bob Foltz reported that he received a second bill from Act One & Associates. The bill was paid on 3/29/19 with check #1137. Act One did not receive the check so they sent the second bill, and they will not charge any late fees. Bob will talk to the bank to see if they will waive the stop payment fee. If so he will issue a new check.

Phyllis Kreiger contacted Bob Foltz and told him the recreation board would be getting a check from Riverview Bank. She did not know the amount of money but it is to be used for playground equipment.

Dave Mills is waiting for an estimate for work to be done to complete Pavilion #2.

John Weldon will contact Carlton Williams to see if he is still going to paint the roof on Pavilion # 2. He will also contact Pyles Garage Doors to have the damaged door repaired when we get the money from football.

John Weldon will see that another plank is placed for the small bridge that washed out across the creek.

Dave Mills reported that he and Dave Linville seeded the ground by the historical plaques, they also repaired a damaged door in the ladies restroom.

Dave Mills introduced Landon Finger and he did a presentation for an Eagle Scout Project. He would like permission to build a Gaga Ball Pit a Wagner Park. The pit would be an octagon and require an area about 26' x 26'. The proposed area would be somewhere between the two pavilions. Jeff Beinhower made a motion to approve Landon's request to build a Gaga Ball Pit. Shawn Fuller seconded the motion. Motion approved.

NEW BUSINESS:

Bob Foltz reported that he issued a replacement check #1143 to Act One & Associates for check #1137 that was never received. The Orrstown Bank placed a stop payment on check #1137 and waived the fees.

Bob Foltz reported that Dave Mills and Dave Linville emptied and cleaned the large cooler. Someone set the temp control to high and everything froze. Need to come up with a way to limit the cold setting.

Dave Mills suggested that we get a load of cracker dust because it is used for various projects at the park. Bob Foltz made a motion to have the township employees get a load of cracker dust for the park. Dave Mills seconded the motion. Motion approved.

John Weldon suggested we get tanbark for around the trees. John Weldon made a motion to get two scoops of tanbark. Dave Mills seconded the motion. Motion approved. Bob Foltz will pay New Blooms for the tanbark and notify the township employees that it can be pickup and spread by one of the summer hires.

John Weldon reported he will contact supervisor Jeff Smith and have him have one of the summer hires spray ball field #1 to kill the grass.

John Weldon reported the trails need trimmed. He will contact supervisor Jeff Smith to ask him to have the summer hires work on clearing the hiking trails.

John Weldon reported that John Jackson (Eagle Scout Project) has the hiking trail from the power line road to Paradise Road cleared and he will be putting in posts to mark the trail.

John Weldon agreed to complete the work on Pavilion #2. He feels he can do the work and not exceed the money budgeted for the project. Thank you John.
