The Wheatfield Township Parks and Recreation Board met on September 15, 2020 at 6:30 p.m.

PRESENT: Shawn Fuller, John Weldon, and Bob Foltz.

SECRETARY'S REPORT:

John Weldon made a motion to approve the minutes of the August 18th 2020 meeting. Shawn Fuller seconded. Motion approved.

Shawn Fuller made a motion to pay the bills. John Weldon seconded. Motion approved.

OLD BUSINESS:

(Carry Over) John Weldon presented the following list of things to do in 2015.

5. Trim Brush on the hiking trails. (Dave)
6. Re-Blaze the trail markers and property boundaries. (Dave)
11. Cut ground level down from large dumpster to bridge (left side of railroad).
12. Build new bridge.
13. Purchase top soil to fill in the area around the pavilion and playground.
15. Purchase and install new playground equipment (this means expanding the playground area)
16. Get more volunteers to help with projects and work details on Wednesday evenings.

Discussion was held and following list of projects was developed for the township employees and summer hire.

1. Clear trails and mark trees on trails.
2. Clear a trail from the loop trail down to the west end of the Paradise Road Bridge.
4. Pressure wash tractor, gator, mower, inside of restrooms.
10. Grade area on field #1 outfield so water can run to the creek.
11. Seal the handicapped fishing deck.

Dave Mills reported that he, Dave Lindville and John Weldon replaced some bad boards on the bridge.

Dave Mills reported that there is no update information on the grant for the bridge project.

Dave Mills reported that the handicap deck still needs sealed and there are some benches that need sealed.

John Weldon reported that Dexter Potter picked up two loads of chipped wood (total 16 cubic yards) from Tuscarora Hardwoods and delivered it to the playground and it has been spread.

John Weldon reported that Jeff Smith was to attend our meeting but did not show.

Bob Foltz reported he received a check from Scott Finger for \$100. It was extra funds he had collected to build the Gaga Ball Pit for his Boy Scout project.

NEW BUSINESS:

John Weldon reported that the bleachers need to be moved off of the multipurpose field. Maybe it can be done Wednesday evening.

John Weldon reported that more chipped wood should be put on the playground. He will contact Jeff Smith and have the township employees get two more loads of chipped wood for the playground.

John Weldon reported the township employees trimmed the ash stump between the garage and the bathroom.

John Weldon provided the following items that need to be done:

Weeds need to be sprayed on Field #1.

Fill holes by the entrance gate.

Downed maple tree at bridge needs to be removed.

Grass needs trimmed at walking bridge.

Clean cobwebs from front of buildings.

Repaint lines for parking spaces.

Haul top soil from Union Cemetery in Duncannon.

See that sign out sheet for zero turn mower is completed and the oil is checked and air filters cleaned before using.

The next meeting will be October 20, 2020 at the township building.

Bob Foltz made a motion to adjourn at 7:30. John Weldon seconded. Motion approved.
