The Wheatfield Township Parks and Recreation Board met on February 16th, 2021 at 6:30 p.m.

PRESENT: John Weldon, Bob Foltz, Dave Mills, Shawn Fuller, Phyllis Krieger and visitor Paul Krieger

SECRETARY'S REPORT:

Shawn Fuller made a motion to approve the minutes of the January 19th, 2020 meeting. Motion seconded by John Weldon. Motion approved by all present.

TREASURER'S REPORT:

Bob Foltz made a motion to accept the Treasurer's Report. Motion seconded by Shawn Fuller. Motion approved by all present.

Bill list was approved for payment. PPL \$33.07

Shawn Fuller made a motion to pay the bills. Motion seconded by Dave Mills. Motion approved by all present.

OLD BUSINESS:

Old projects to be done.

1. Trim Brush on the hiking trails.
2. Re-Blaze the trail markers and property boundaries.
3. Cut ground level down from large dumpster to bridge (left side of railroad).
4. Build new bridge.
5. Purchase top soil to fill in the area around the pavilion and playground.
6. Purchase and install new playground equipment (this means expanding the playground area)
7. Get more volunteers to help with projects and work details on Wednesday evenings.
8. Clear a trail from the loop trail down to the west end of the Paradise Road Bridge.
9. Pressure wash tractor, gator, mower, inside of restrooms.
10. Grade area on field #1 outfield so water can run to the creek.
11. Seal the handicapped fishing deck.
12. Spray weeds on ball fields.
13. Fill holes by the entrance gate.
14. Remove downed maple tree at the bridge.
15. Trim Grass at the walking bridge.
16. Clean cobwebs from front of buildings.
17. Repaint lines for parking spaces.
18. Haul top soil from Union Cemetery in Duncannon.
19. See that sign out sheet for zero turn mower is completed and the oil is checked and air filters cleaned before use

Dave Mills reported that due to weather he did not make the supervisor meeting and did not hear anything on if a new permit is needed to build the bridge or not.

Bob Foltz reported he is still waiting on order of two soap dispensers that are still not available, he will order them when they are back in stock.

Shawn Fuller stated he contacted Smith's Farm Equipment and got a price to service the Z-28 mower. (actually, a ZD-28 Zero turn mower) of \$332.66 which would include; oil change, oil, filters, fluid, steam clean, sharpening, hauling, misc shop charge, checking for leaks, service battery, tire pressure, check breaks, etc. On motion of Bob Foltz seconded by Dave Mills, Motion approved by all present. Shawn will set this up.

NEW BUSINESS:

Ron Baker contacted John Weldon to reserve the field for girls' softball. Ron will send Liability insurance and will be in touch with John to schedule dates.

Shawn asked if they offered an extension on the grant because of covid. They are still waiting on permit. The possibility of getting a crane to set old bridge off was discussed, Bob wondered if whoever bids should take care of the teardown. An addendum to the bridge package should be included to include setting the old bridge off and putting in new beams.

Paul volunteered, out of the goodness of his heart, to install a camera system at Wagner Park. He will need a place for a shelf, near power. Paul will provide specific models, quantities, and prices. Phyllis will add to budget. On motion of Shawn Fuller seconded by Dave Mills, Motion was approved by all for Paul to submit proposed bill for estimated material cost.

The next meeting will be March 16th, 2021 at the township building.
John Weldon made a motion to adjourn at 7:45. Dave Mills seconded. Motion approved.
