The Rec Board also discussed how to move forward as far as operating expenses needed for miscellaneous supplies and services required to maintain the park. It was stated that the Twp. has an account at Hellers Hardware in Newport with a \$500 line of credit that could be used.

David Mills noted that in the past the Rec Board purchased and maintained trash bags, rest room products, and cleaning supplies along with numerous other items needed for the Park. These items were picked up and delivered by members and volunteers.

This along with many other items will need to be discussed with the BOS's on how we operate in the future.
