The first agenda item was the David & Susan Beatty/Lester Nace Subdivision Plan.

All members seemed in favor of the revisions and to prepare it for presentation to the BOS's for approval.

### **Visitors Comments:**

Lester Nace spoke on the status of a Communication Tower Site on Montebello Farm Rd. He noted the owner is moving forward with alterations though no Land Development Plan has been submitted.

Ed Womer commented on Building Heights and setback lines in the Twp. He also said he has begun going through the Twp. Zoning Ordinances for his position as Alt Zoning Officer.
