Information was also discussed concerning the bridge on Paradise Rd. at Wagner Park. It is being looked at for rehab or replacement and suggestions for design and improvements are being requested. David M. will draft a letter from the Rec. Board and WTPC about this.

David M. reported the SALDO revision hearing will be at 6:45 PM March 5^{th} , 2018 before the BOS meeting.
