#### Discussion:

A motion was made to grant the 6 AOR's requested with the plan. Dave J. made the motion for the AOR's, Travis 2<sup>nd</sup>, all were in favor. After another short discussion a motion was made to "Table" the plan until the additions and corrections have been addressed. David M. made the motion to "Table" the plan, Tom 2<sup>nd</sup>, all were in favor.

#### Other Action:

There was some discussion that arose while discussing the plan about looking into adding a Stand Alone Ordinance on storm water management into the SALDO requirements.

Jim Fuller requested that the WTPC look into Well Isolation areas that cross property lines and are not entirely on the lot they serve. The WTPC will look into this at future meetings.
